OVERVIEW BANGLADESH

Bangladesh is the most densely populated country in the world, with a population of 167 million in a territory the size of Iowa. It has a young population that is eager to work. The median age in Bangladesh is 27.9 years, and 65% of the population is of working age.

The GDP growth rate was consistently over 6% in the last decade and was 7.1% in 2022. The RMG industry and foreign remittances primarily drive this growth. Bangladesh's Foreign Direct Investment (FDI) stock was \$20.87 billion through the end of September 2021, with the United States being the top investing country with \$4.1 billion in accumulated investments.

Most people in business settings speak English. 41% of the population has internet access, and 99% have access to a cellphone. There is a rapidly growing IT sector, with over 650 million IT freelancers.


