# **Talent Shortage**

Several factors have contributed to a lack of rising CPA talent, which has been a years-long trend, including the barriers they must hurdle to gain certification, such as time and cost, competition for talent from other fields of study, and student's perception of the accounting industry. As with some other professions, the workplace and the workforce are changing. Modernization is imperative as firms prepare for an influx of a digital-native workforce with distinct expectations and demands.

The World Economic Forum, back in 2020, predicted that over <u>half of the workforce would be</u> <u>remote</u> in the coming years. And they weren't wrong. Today, 12.7% of full-time employees are working from home, with 28.2% embracing a hybrid model. By 2025, <u>Upwork predicts nearly</u> <u>32.6 million</u> Americans will be on remote work.

# The Impact on Firms


Missed growth opportunities and misinformed decision-making: The accountant

#### 2. Become a virtual organization





### **Our Advice in Managing Remote Workers:**

- Onboard consultants just as you would any other employee
- Communication is key: consistent check-ins and feedback. Set the expectation for areas of excellence and areas of improvement
- Multiple time zones: physically map out when co-workers overlap for optimal communication. Include times when people are "off" to respect life/work balance
- Emphasize digital collaboration: slack, teams, google chat- emphasize its importance
- Provide teams with clear roadmaps for the entire team
